## RESOLUTION NO. 31 OF 2024 AUTHORIZING THE COMMENCEMENT OF NEGOTIATIONS FOR THE ACQUISITION OF REAL PROPERTY PARCELS UNDERLYING THE EKLECCO EASEMENTS FROM EKLECCO II LLC

**Phillips:** Executive Director, can you give us a brief explanation?

**Damiani:** In 1989 Eklecco granted the Town of Clarkstown two easements. Easement one consisting of 0.716 of an acre and easement two consisting of 6.08 acres. Both easements were subsequently assigned to Rockland Green under the acquisition of the Clarkstown solid waste facilities in 2009. Both easements were for 25 years and expired on May 29 of 2023. Rockland Green is currently operating a portion for the concrete and asphalt crushing operations and yard waste composting operations under an extension of those assigned easement agreements. Currently we are in our fifth extension which is set to expire August 31, 2024. In accordance with our guidelines for acquisition of real property, Rockland Green has obtained two appraisals the evaluation for all four parcels. In addition to the easement for the interest we already have in real property we are looking to acquire a total of 14.3 acres which encompasses four separate tax parcel I.D.'s. The evaluation for all parcels ranges between \$3.2 million and \$4.3 million. Rockland Green has made an informal offer of \$2.3 million contingent upon Eklecco delivering all four parcels. The concern currently is that two of the parcels are listed on Pyramid's Mall site plan from 1987 and incorporate both requirements for the mall. Pyramid will have to seek approval from the Town of Clarkstown's Planning Board to amend their site plan. How this would impact us is if we could not extend the easement or require the parcels 6.27 acres is the size of the existing compost pad, we currently own half of it, so the balance is part of Eklecco's property.

**Phillips:** I think that leads us to the point where we need to acquire the land.
